Once two libraries decide to partner, they establish the level of commitment that they are both comfortable with; the partnership can be as formal or informal as desired. ## Librarian Emma Boettcher Returns to *Jeopardy!*

In the first two weeks of November, record-breaking *Jeopardy!* contestant James Holzhauer will return to the show to take on the University of Chicago librarian who ended his winning streak earlier this year. Holzhauer, who saw his 32-game winning streak come to an end in June and finished \$58,484 short of Ken Jennings's all-time winnings record, will face [Emma Boettcher](#) (right) in *Jeopardy!*'s annual Tournament of Champions. In addition to Boettcher and Holzhauer, the field includes the 13 other players who've won the most games since the previous tournament. The 10-day event concludes with a \$250,000 grand prize for the winner.



## ALSC/Candlewick Press "Light the Way" Grant

The Association for Library Services to Children and Candlewick Press offer the "Light the Way: Outreach to the Underserved" grant, created to honor Newbery Medalist and Geisel Honoree author Kate DiCamillo and the themes represented in her books. The award consists of a \$3,000 grant to assist a library in conducting exemplary outreach to underserved populations through a new and innovative program or an expansion of work already being done.

## Libraries Take the Lead in Teaching Cursive

*American Libraries Trend, Sept./Oct.*

Marcus Banks writes, “At the Richland Library Main Makerspace and Woodshop in Columbia, South Carolina, patrons can use a band saw, learn their way around a sewing machine, or join a ‘build-a-thon.’ But in 2019, one teenage user expressed a different goal: To sign her name, rather than print it. That led Teen Services Supervisor Jennifer Naimzadeh to decide that her branch should offer workshops in cursive writing. Supporters of cursive point to [a study from 2012](#) finding that reading and writing cursive may help prevent the reversal and inversion of letters by students with dyslexia.”


